Dear Boat Owner

FRINGE BY THE SEA 2nd to 11th AUGUST, 2019

As advised at the time of your application for a dinghy park space, NBHTA are supporting the Fringe by the Sea (FbtS) festival again this year by making space available on the Esplanade and dinghy park. The performances at the festival will take place during the above dates. To allow time to set-up, all boats and trailers must be removed from the dinghy park by **Wednesday 31st July at 9.30pm**. Access to return boats etc. will be available from **mid-day on Wednesday 14th August**.

This year there are three overlapping events needing temporary space on Elcho Green: the Senior Amateur Golf Championship; the Aero Dinghy UK National Championships and optional storage for dinghy park boats. FbtS have made arrangements with East Lothian Council to have Elcho Green available as an option for you to store your boat from Saturday 27th July to Saturday 17th August; see drawing below.

1. Limited space is available over the weekend of 27th/28th July – blue area
2. As Aero dinghies depart from the evening of 28th July, more space is available – red area.
3. All dinghy park boats should be moved from the blue area to the red area as space becomes available

The extreme east end of the green needs to be kept clear on Saturday 17th August (green area). Charges incurred by boats left on the green after 17th August will be passed to the owners.

Please park dinghies neatly facing the sea to allow pedestrian passage between them. Please do not take trailers/trolleys on to the putting green.

NBHTA extends its thanks to all those who moved their own boats and trailers timeously in previous years and we are confident that the vast majority will do so again.

Last year we succeeded in clearing the Esplanade of all boats and trailers. However a very small number of boat owners failed to remove their boats and NBHTA members and volunteers had to clear the Esplanade. This was extremely unsatisfactory for all concerned. Please remove your boat, trailer and any other items which are stored on the dinghy park or Esplanade during the times above to facilitate the set up and running of Fringe by the Sea.

Any boats, trailers or other items which are not removed in good time will be moved in accordance with the Harbour Management Rules and it is highly probable that access to them will be severely restricted.

Please be aware that any failure to comply with this notice will be taken into account when the annual renewal is due and may result in the offer of a space being withdrawn.

As always, your assistance with this matter will be greatly appreciated by NBHTA, Fringe by the Sea organisers and the wider community who come to our harbour to enjoy the Festival.
